ORDER

Sub: Appointment of "Returning Officer" and the "Election Programme" for Conduct of Election of "GP Parsik Sahakari Bank Limited", Dist. Thane, Maharashtra – 421204. -reg.

1. The Cooperative Election Authority has been established under Section 45 of the MSCS Act, 2002 (as amended in 2023). As per Section 45-I of the said Act, the Authority discharges the following functions :-

- i. Conduct of elections of the multi-state cooperative society;
- ii. Supervise, direct and control the matters relating to preparation of electoral rolls; and
- iii. Such other functions as may be prescribed.

2. Accordingly, in exercise of the powers conferred by Section 45 K (1) of the Multi-State Co-operative Societies (MSCS) Act 2002, as amended by the MSCS amendment Act 2023 read with Rule 19F (a) of the MSCS Rules 2002, as amended with MSCS Rules in 2023, the Co-operative Election Authority hereby appoints **District Magistrate/Collector, Thane** as Returning Officer for conducting Elections of the society as per details given in subsequent paras.

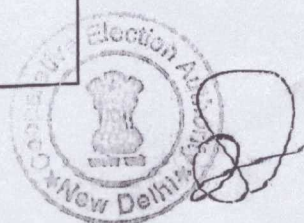

4. Detailed relevant instructions on conduct of election are attached at Annexure-I.

5. RO is requested to ensure the election is conducted as per the MSCS Act, 2002 as amended by MSCS (Amendment) Act 2023 and Rules framed thereunder. In case any provision of Bye-Laws of the Society is inconsistent with the provision of Act and Rules made thereunder, then provisions of the Act/Rules shall prevail over such in-consistent provisions of the Bye-Laws and decision taken by CEA in this regard shall be final.

5.1 A meeting had taken place through VC on 09.04.2026 and during the meeting the following was informed by the Chief Executive of the Bank. Accordingly, following directions are given under Section 45L of the MSCS Act:

"All shareholders of the Bank are eligible to vote. Each, one has one vote. They can't be denied right to vote on the basis of number of shares held as stipulated in Bye-Laws No. 10 (ii); accordingly, the Board of Director of the Bank is directed to get Bye-Laws 10 (ii) suitably amended to enable every ordinary member to participate in voting."

6. Implementation of Banking Regulation Act 1949:

(i). "As per recent amendment in Section 10A (sub-section 2a(i) of the Banking Regulation Act, 1949 (BR Act), the maximum continuous tenure of directors of



cooperative bank (excluding Chairperson and Whole-time Directors) has been extended from 8 to 10 years. This provision has come into effect from 01st August, 2025".

(ii). Accordingly, Returning Officer shall ensure implementation of this amended provision and seek details tenure of Directors, disqualification of any director or any penalty imposed by RBI having bearing on elections of board of directors and officer bearers. Managing Director of the Bank shall furnish all the documents as sought by Returning Officer as to conduct election in transparent, free and fair manner.

(iii) Such directors who have completed a continuous tenure of 10 years on or after August 1, 2026 is ineligible to contest in the election of Board of Director & Office Bearers.

7. RO may submit proposal for appointment of adequate number of ARO
8. The Constituency shall be as per registered and approved Bye-Laws of the Society. **Every voter member has a right to elect all the directors individually and as per Bye-Laws.**
9. RO is advised to go through the documents meant for conduct of election- namely preparation of member list, preparation of voter list and information relating to seeking prior approval of Board of Directors and Office Bearers. These documents are available on the website <https://cres.gov.in> under the heading "Cooperative Election Authority" (Handbooks of Returning Officer). Instructions contained in these documents must be followed in letter and spirit so as to ensure free and fair election.
10. A Checklist for RO is attached for monitoring the election process and recording various important information and details. (Annexure II).
11. This issues with the approval of Cooperative Election Authority.
